As of May 25th, 2018, the new European regulation on data privacy will come into force and replace the current European Directive on data privacy of 1995.

This regulation is automatically applicable in every country of the EU, and aims to simplify European legislation on data privacy. The **General Data Protection Regulation or GDPR** does not fill all data privacy gaps and leaves some freedom to individual European countries to independently regulate certain areas.

Under the GDPR companies processing the personal data of European citizens (or any person residing in Europe at the time the data is processed) will need to comply with the Regulation as well as with any additional privacy laws and regulations imposed by individual European countries where the data is processed and collected.
